# Norsk Carolina Lodge Norway Tour 2010 Terms & Conditions

## TRAVEL DOCUMENTS

**U.S. Citizens must be in possession of a valid passport with not less than six months validity remaining. Non U.S. Citizens should consult the appropriate consulates.**

## DEPOSITS AND PAYMENT

A deposit of \$400 per person for the *Norsk Carolina Lodge Norway Tour* should be submitted with the completed and signed reservation form to confirm your booking.

**The trip balance is due no later than May 21, 2010.**

## RATES AND FARES

Prices are based on guaranteed, advanced bookings at Borton Overseas' contract rate with each supplier (i.e. hotels). The quoted cost represents a complete package price and an itemization of individual component cost will not be rendered.

**Cancellation Policy:** Full refund, less \$50.00 administrative fee per person, if cancellation is received in writing on or before April 1, 2010. Between April 2 and May 20, 2010, the deposit is non refundable. Cancellation notice received after May 20 will be assessed the following fees: May 21 – June 14, 50% of tour cost; June 15 or later, no refund. No refund can be made for any tour accommodation, service or feature that participants do not utilize or voluntarily change; if participants cancel while tour is in progress, there will be no refund for unused portions.

**Travel Insurance for trip cancellation/trip interruption and medical emergencies is available and highly recommended.**

## Baggage

**Please note:** *US Airways* allows **1 checked piece** of luggage up to 50 lbs. The second checked piece (maximum 50 lbs) will cost \$55, payable at the airport at check-in.

As carry-on, *US Airways* allows **1 personal item** (purse, briefcase or laptop bag) **plus 1 carryon piece**, maximum 40 lbs, and maximum 45 linear inches (length + width + height).

## FREQUENT FLYER NUMBERS

Frequent flyer numbers must be supplied to us along with your reservation. Passengers are responsible to reconfirm their number with the airline upon check-in for flights.

**PLEASE NOTE:** A fee of \$25 per passenger will apply should we need to provide ticket copies to obtain frequent flyer mileage credit.
